ABOUT ABS-CBN FOUNDATION, INC

ABS-CBN Foundation, Inc (AFI) aims to awaken hope in Filipinos by implementing projects with multi-sectoral partnerships that bring out the spirit of Bayanihan. The five advocacies of ABS-CBN Foundation are Disaster Risk Reduction and Management, Children's Rights and Development, Education, Environmental Stewardship, and Sustainable Livelihood.

The programs of ABS-CBN Foundation have evolved and remained responsive to the times through the decades.

Bantay Bata 163 was founded in 1997 to provide child protection and support family development. Its flagship programs include Hotline 163 and the Children's Village. Bantay Bata 163 also offers medical and educational assistance to children at risk, abused children, and children from disadvantaged families. Bantay Bata 163 has extended its services to include interventions that address mental health, particularly of children and their caregivers.

Bantay Kalikasan soon followed Bantay Bata in 1998. Its history is rich in implementing projects that aim to protect and enrich our country's natural environment. Its major projects include the Rehabilitation of the La Mesa Watershed and Ecopark, "Kapit Bisig Para sa Ilog Pasig", Bantay Baterya and Langis, and the Green Initiative.

Sagip Kapamilya was formally organized into a program in 2004. Sagip Kapamilya is present during humanitarian crises in the country. It specializes in early recovery efforts, needs-based rehabilitation, and disaster risk reduction projects.

Programa Genio designs and implements school development programs and projects that contribute to the national goal of basic education. It helps senior high school programs of its adopted schools assist

students with the greatest need. These programs are conducted mostly in disaster-prone areas.

In 2021, AFI began employing an Integrated Area Development (IAD) Framework to empower and provide inclusive opportunities for Filipinos so they can make positive transformations happen - one community at a time. The IAD Framework is anchored on social justice, empowerment and self-determination, and collective impact by employing an integrated approach, social entrepreneurship, technology and innovation, dynamic partnerships, and fusion of indigenous wisdom with global trends and local actions. It is relevant because AFI believes that development goals are interconnected, with each collaborator having a sharp focus area and the orchestrated whole achieving a more profound impact.

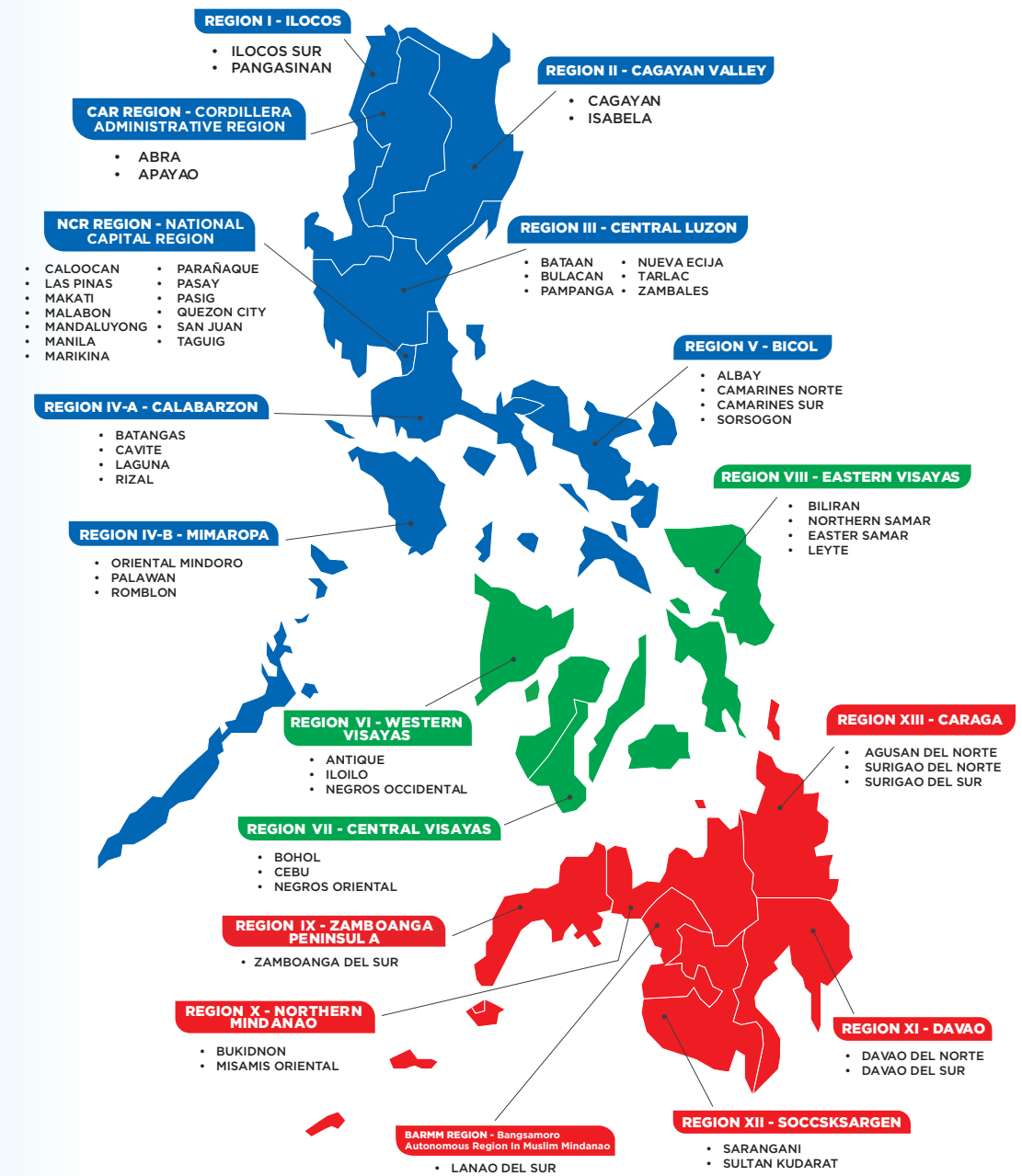

The Philippines sits within a region that is highly susceptible to natural disasters such as typhoons, earthquakes, volcanic eruptions, and floods. These natural phenomena can cause significant damage to infrastructure, homes, and livelihoods, and can lead to loss of life and displacement of communities.

For decades, ABS-CBN Foundation has been at the forefront of providing immediate aid and relief, but our belief in holistic disaster risk reduction and management has guided us toward more sustainable support for affected communities.

Alongside providing aid and relief, Sagip Kapamilya sought to help communities rebuild and recover from the damage brought by these calamities through providing humanitarian aid and disaster preparedness trainings.

Solar-powered potable water systems are crucial in ensuring water quality and availability in far-flung areas such as Sitio Gilun, Marilog, Davao del Sur. Since it accesses water from deeper ground levels, they remain operational even without electricity, which is crucial during extreme weather events. In August 2023, the Sagip Kapamilya team turned over a solar-powered potable water supply system to Noemi’s community.

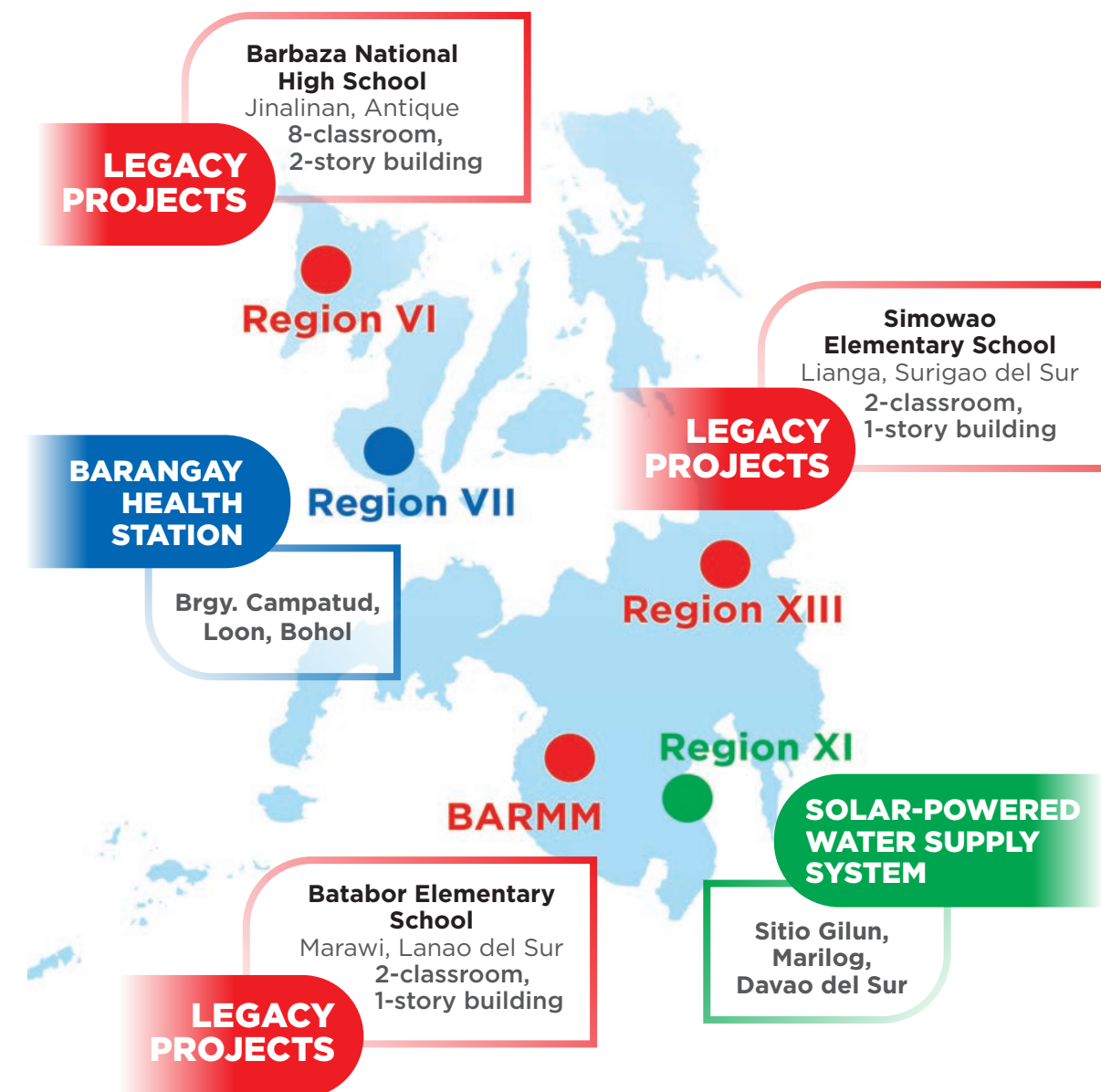

Before carrying the name “Legacy Projects,” this initiative started off as school-rebuilding projects in the aftermath of Super Typhoon Yolanda. Since 2018, we have launched 8 Legacy Projects under Sagip Kapamilya, with the Barbazza National High School being the last school to be turned over.

The ABS-CBN Foundation team assigned to turnover the Legacy Project was met with the warmest of welcomes by the Barbaza community. Alongside the blessing of the building came a promise from the Barbaza community to cherish this gift and maximize its impact for the future of its learners. 1,797 learners, 55 Junior High School teachers, 12 Senior High School teachers and 2 provincial-provided ALS Senior High School teachers will benefit from this legacy project led by Engr. Jojo.

In collaboration with local government units, Sagip Kapamilya conducted Disaster Risk Reduction and Management (DRRM) training sessions tailored to high-risk areas and the disasters LGUs typically weather. This year, around 200 participants attended these trainings held in disaster-prone provinces, including Northern Samar, Camarines Sur, and Leyte. Among our partners was the EDMERO Unit of Camarines Sur led by Clyde.

Accounts like that of Nanay Penny resonated across the affected localities as the daily lives of Mindorensos were disrupted and brought to a halt by the oil spill.

While storms may hinder coastal communities from earning revenue for a few days as strong winds and waters make it difficult to fish, an oil spill effectively puts a stop to all fishing until an area is deemed oil-free, which could take weeks to months.

With fishing and ecotourism at a standstill, fishing villages relied on the support of organizations like the ABS-CBN Foundation, national and local government agencies, and the Foundation’s partners to manage their day-to-day.

MINDORO OIL SPILL: Protecting Communities and Coastlines

In February 2023, the Philippines was hit with another environmental disaster when the **MT Princess Empress** spilled over **200,000 gallons of crude oil** into the coast of Mindoro Island.

The effects of the oil spill were devastating. Thousands of fish and marine life were killed, and the local fishing industry was decimated. The oil also washed up on the shores of the island, coating the sand and rocks and making it impossible for tourists to visit the area.

As fishing and ecotourism bans stunted livelihood in many of the coastal communities in Mindoro towns, there was a need to come together to support our Kapamilyas in their fight for survival. **ABS-CBN Foundation, through the collaboration of its programs Sagip Kapamilya, Bantay Kalikasan, and Bantay Bata 163, provided immediate relief and assistance to the affected local communities.**

From food packs, hygiene kits, spill boom materials, medical missions, to psychosocial support for children and their caregivers, the goal was to aid coastal communities and frontliners in Pola, Naujan, Baco, and Bongabong in Oriental Mindoro.

When our partner communities are in need, the ABS-CBN Foundation seeks to bring Kapamilyas together in their aid.

For People, For Planet – TOGETHER:

Engaging Stakeholders in Environmental Conservation and Governance

Since 2022, the United States Agency for International Development (USAID) via Gerry Roxas Foundation (GRF) has been supporting the coastal communities in Batangas, Romblon, and Mindoro through our citizen science reef monitoring initiatives.

When the oil spill hit the shores of Mindoro, USAID and GRF recognized the innate interconnection between protecting the coastlines from further damage and supporting coastal communities.

This support first came through donations of food packs, hygiene kits, spill boom materials, and psychosocial support for children and their caregivers. Through the support of ABS-CBN Lingkod Kapamilya, this first wave provided short-term yet swift support as they weathered the immediate devastation of the oil spill.

This was followed by a long-term action plan to equip coastal communities with the most accessible means to assess their municipal waters.

If local communities are capacitated in mangrove and coral reef assessment methods and are empowered to conduct monitoring, then they can become citizen scientists and vital partners in Natural Resource Security and Governance (NRSRG). If capacitated, these community citizen scientists will be able to collect and process data on the state of the corals, and mangroves, then they generate scientifically valid reports consistent with the reporting standards and protocol.

Upon lifting of ban of water activities in affected municipalities, the OrMin INSPIRE Project started discussions with LGUs and project partners in Oriental Mindoro to identify priority sites for its biophysical assessments (mangrove and coral reef) component of the project.

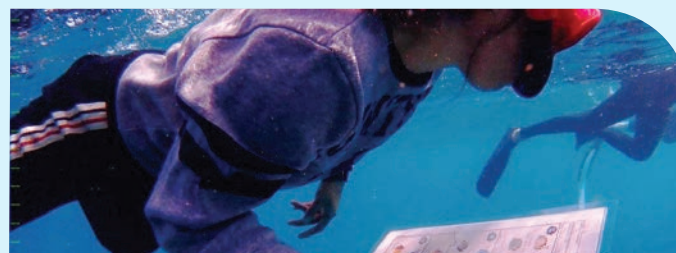

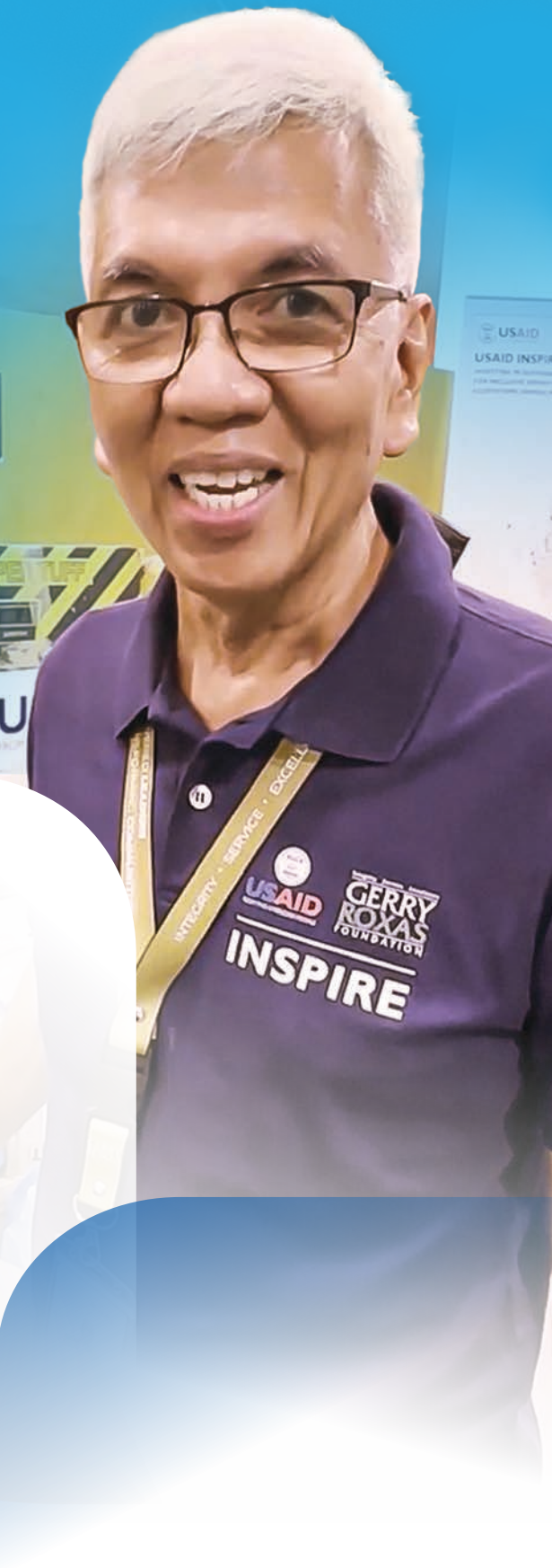

ENVIRONMENTAL STEWARDSHIP IN 2023

Since 1998, the ABS-CBN Foundation has been dedicated to addressing numerous environmental challenges, including air and water pollution, deforestation, improper waste management, sustainable agriculture, ecotourism, and rehabilitation from the aftermath of typhoons.

Since its inception, the program has implemented significant projects such as rehabilitating the La Mesa Watershed and La Mesa Ecopark, cleaning the Pasig River, and engaging communities for the protection of marine ecosystems.

In 2023, Bantay Kalikasan's programs on Citizen Science, Environmental Education, and Advocacy for Philippine Biodiversity and Sustainable Communities continue to gain momentum and scale.



LA MESA WATERSHED AND ECOPARK: NURTURING GREENER FUTURES FOR FILIPINOS

In 1999, Bantay Kalikasan took action to reforest the La Mesa watershed in response to the imminent decommissioning of the La Mesa reservoir due to extensive disturbance from illegal settlers and farming activities.

Over 24 years, the Foundation restored 89% of the forest by planting more than 1.3 million trees to reforest over 1,500 hectares of land, with an impressive survival rate of 92.5%. The forest now boasts 105 tree species, 94 of which are native to the region. Additionally, almost 150 species of birds have returned to the area, signaling a return of wildlife.

This 2023, 65 partners including schools, private companies, fellow civil service organizations, and even rising stars in Philippine show business brought their communities to the La Mesa Nature Reserve and the La Mesa Ecopark to learn more about the impact that green spaces like watersheds can have in keeping the air we breathe and the water we drink clean.

This 2023, Chunsang Jung was joined by her fellow Star Magic Freshies Jana Agoncillo, Krystal Mejias, Mutya Orquia, Hannah Vito, Angelika Rama, Heart Ramos, Marc Santiago, Raikko Mateo, Andre Del Rosario, Miguel Vergara, and Lance Lucido, alongside Krystal Brimmer, for a visit to the La Mesa Ecopark and La Mesa Nature Reserve. Here, they learned about the importance of the La Mesa watershed, which supplies water to residents of Metro Manila. As these Star Magic Freshies continue to grow into individuals who truly care for their environment, the ABS-CBN Foundation hopes that they can use their massive platforms to clamor for greener futures for Filipinos.

CITIZEN SCIENCE: COMMUNITIES CHARTING UNKNOWN WATERS

The ABS-CBN Foundation has always operated from an understanding that very little can be achieved alone. And this belief resounds even in the way it supports partner communities in coastal areas.

While La Mesa may be the Foundation's focus on land, the Verde Island Passage (VIP) has its full attention on water.

Citizen scientists are key to the protection of the 1.14 million hectares of the VIP. As one among many colleagues concerned about the center of the center of marine biodiversity in the world, the Foundation has zeroed in on specific communities in Batangas, Mindoro, and Romblon.

Through reef, mangrove, and seagrass monitoring workshops, locals are empowered as citizen scientists to protect their surrounding marine communities. With the help of low cost but accurate equipment, these local stakeholders are now able to gather critical data on the health of their marine ecosystems.

One of the key funders supporting this effort is the United States Agency for International Development (USAID) via Gerry Roxas Foundation's (GRF) Investing in Sustainability and Partnerships for Inclusive Growth and Regenerative Ecosystems (INSPIRE) Project. Through INSPIRE, ABS-CBN Foundation launched "Bantay Bahura," which centers on marine conservation through citizen science reef monitoring.

Launched in 2022, this year marked the pilot year of the project. Under Bantay Bahura, ABS-CBN Foundation rolled out Citizen Science reef monitoring workshops using the ALWAN method, a term coined from Batangas' "maalwan" which means "at ease." In one year, we were able to train 93 citizen scientists from eight (8) cities and municipalities: Lobo, Mabini, and Tingloy, Batangas, Batangas City, Puerto Galera, Oriental Mindoro, Tablas, Looc, and San Agustin, Romblon.

Regarded as the center of the center of marine biodiversity in the world, the Verde Island Passage (VIP) has long captured the attention of marine conservationists due to its exceptional biodiversity. Prior to 2010, the VIP has shown little evidence of coral bleaching in the 20 years of research conducted in the area by that time. After a coral bleaching event in October 2010, the VIP has proved naturally resilient, showing signs of recovery after just four months.

One of the most powerful conservation forces of this 1.14-million-hectare marvel has been the collaborative effort of local communities, academia, nonprofit organizations, and government agencies. To discuss further action in support of this international recognition, ABS-CBN Foundation, together with its partner organizations and scientists, met with Hon. Loyzaga after the VIP was named a Mission Blue Hope Spot.

At the heart of the ABS-CBN Foundation's marine advocacy, you will find the Verde Island Passage (VIP). A major waterway that separates southern Luzon Island from northern Mindoro Island in the Philippines, it spans millions of hectares of coral reef, mangrove, and seagrass habitats.

Abundant marine environments are the bread and butter of the Philippines, but what sets the VIP apart is that it's the center of the center of marine biodiversity in the world. With the advocacy of scientists like Dr. Kent Carpenter, Dr. Terrence Gosliner from the California Academy of Science, and Dr. Wilfredo Licuanan from the De La Salle University, the VIP was launched into worldwide visibility.

In 2023, the Verde Island Passage was named a Hope Spot by Mission Blue, a renowned international marine conservation nonprofit dedicated to global efforts for ocean exploration and protection.

While Dr. Terrence Gosliner from the California Academy of Sciences and Dr. Wilfredo Licuanan from the De La Salle University have been named Hope Spot Champions for spearheading the nomination, partners like the ABS-CBN Foundation, Pusod Inc., Old Dominion University, VIP Center for Oceanographic Research and Aquatic Life Sciences (VIP CORALS) Batangas State University, and First Gen Corporation have similarly nurtured the network of marine protected areas (MPAs) in the VIP.

With threats like the Mindoro Oil Spill looming over its shores, the recognition of the VIP as a Mission Blue Hope Spot accentuates the urgency of collaboration in conservation.

“Just less than a month after joining the team, I gained a deeper understanding of the child protection concerns and needs of the Filipino children in general, and of our partner schools, to be specific. More so,

it encouraged me to support the work of Bantay Bata 163 — a sense of responsibility that transcends the limits of my employment contract, and instead comes from a genuine drive to be in the service of the Filipino children.”

CHILDREN'S RIGHTS AND DEVELOPMENT IN 2023

Witnessing the plight of abused, neglected, and abandoned children, Gina Lopez envisioned a safe space where they could be heard and supported. She brought this vision to life on Valentine's Day in 1997, when she established Bantay Bata 163 and heartily called it, “a gift of love to Filipino children.” Bantay Bata is one of the first flagship programs under the ABS-CBN Foundation and pioneered the first rescue hotline for Filipino children in crisis.

This 2023, Bantay Bata remains true to its founder's vision—to be a stalwart force for children's rights and protection, further strengthened by championing the message of “Tayo ang Bantay Bata” through its initiatives.

Renamed **Helpline 163**, the renowned child-focused hotline now offers a broader array of services beyond reporting of abuse cases, including free psychological counseling and consultation for children, teens, and caregivers. Amid the COVID-19 pandemic, Bantay Bata Helpline 163 adapted by expanding onto Facebook and Messenger, resulting in these platforms now hosting the highest number of valid contacts. The numbers 1-6-3 remain a symbol of hope for children across the country.

CHILD SAFE SCHOOLS

For 2023, the Child Safe Schools project redirected its focus to the Visayas island group, driven by studies indicating a high prevalence of Online Sexual Abuse and Exploitation of Children (OSAEC) in the area.

Bantay Bata responded to this need through Project MIND (Mental health Intervention for Children Need/affected by Disasters) and Kodi was among the student volunteers in Manila and Oriental Mindoro installments of the project.

The pandemic made Bantay Bata recognize the value of physical interactions in a child's development that digital platforms could not fully replicate. As restrictions eased in 2023, the program worked to resume in-person gatherings, and the perfect opportunity came in the form of a National Children's Month celebration.

In partnership with Berge Bulk and Marshall Foundation, alongside other donors and partners, Bantay Bata facilitated its first face-to-face Children's Congress in November. This year's highlight event celebrates the simple joys of childhood, while raising awareness about children's rights.

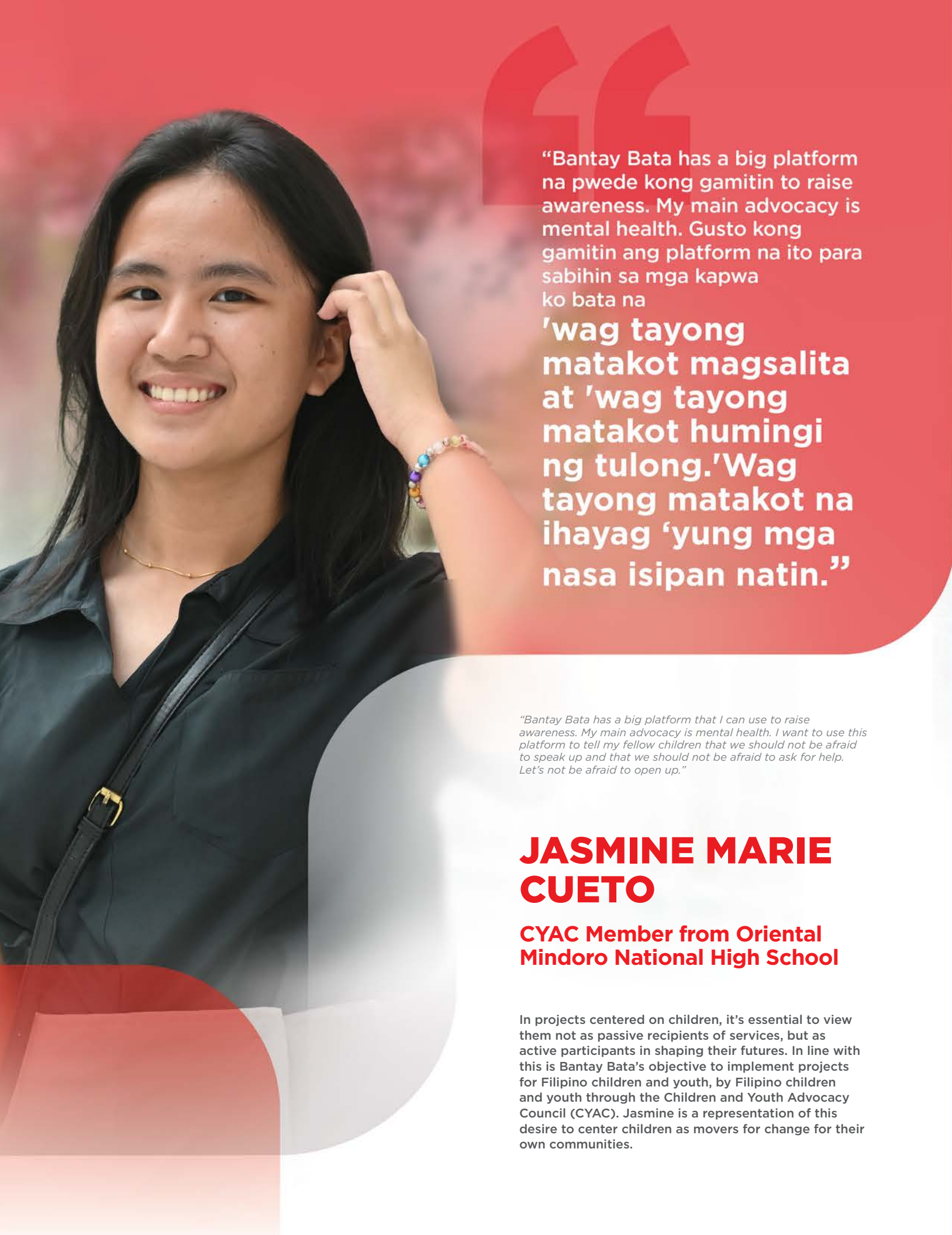

In line with this is Bantay Bata's objective to implement projects for Filipino children and youth, by Filipino children and youth through the Children and Youth Advocacy Council (CYAC). Jasmine is a representation of this desire to center children as movers for change for their own communities.

In the same event, Bantay Bata proudly launched its newest initiative set to be integrated into its core projects in 2024 — the **Children and Youth Advocacy Council (CYAC)**.

The CYAC represents building capacities by engaging children and youth in Bantay Bata's program delivery. The project will enable them to assess their sector's needs and create

opportunities to amplify the voices of their fellow children and youth.

SUSTAINABLE LIVELIHOOD IN 2023

Integrated Area Development (IAD) embodies ABS-CBN Foundation’s sustainable livelihood advocacy. Central to IAD’s strategy is its application of grassroots interventions and a bottom-up approach to community building. At its essence, these approaches revolve around the principle of empowerment and local participation, recognizing that true change begins from the very communities it seeks to uplift. IAD is designed to harness local knowledge and resources, and in doing so, community members became actively involved in the trajectory of their own development.

Among the projects turned over this 2023 was the Barangay Panganiban Mangrove Boardwalk, in partnership with Sun life Foundation. Through this boardwalk, the Tulay sa Tibo People’s Organization in Sorsogon will further integrate citizen science and ecotourism.

Report on the Audit of the Financial Statements

Opinion
